The Directors present their report and the audited financial statements of Gaslink Independent System Operator DAC ('the Company') for the year ended 31 December 2019.

## **PRINCIPAL ACTIVITIES AND FUTURE DEVELOPMENTS**

The Company is a dormant subsidiary of Gas Networks Ireland.

The Company ceased to trade on 1<sup>st</sup> August 2015 and the Company's trade was transferred to Gas Networks Ireland. The Company did not trade during the financial year ended 31 December 2019. As noted the Company is dormant and currently there are no plans for future activity.

## **PRINCIPAL RISKS AND UNCERTAINTIES**

The directors are responsible for preparing the directors' report and the financial statements in accordance with the Companies Act 2014.



### Report on the audit of the financial statements

#### Opinion on the financial statements of Gaslink Independent System Operator DAC (the 'company')

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 31 December 2019 and of the result for the financial year then ended; and
- have been properly prepared in accordance with the relevant financial reporting framework and, in particular, with the requirements of the Companies Act 2014.

The financial statements we have audited comprise:

- the related notes 1 to 10, including a summary of significant accounting policies as set out in note 1.



### **1. General Information**

Gaslink Independent System Operator DAC ('the Company') is a designated activity company ("DAC") incorporated in Ireland. The Company's registered office is Gasworks Road, Cork. The Company number is 447782. The Company did not trade during year end 31<sup>st</sup> December 2019. Gaslink was the Transmission System Operator (TSO) and Distribution System Operator (DSO) responsible for operating, maintaining and developing Ireland's natural gas transmission and distribution systems. Gaslink ceased to trade on 1<sup>st</sup> August 2015 and the Company's business and activities were transferred to Gas Networks Ireland.

### **2. Basis of Preparation**

The financial statements are presented in Euro and have been prepared under the historical cost convention. The directors continue to adopt the going concern basis in preparing these financial statements.

#### **(a) Statement of Compliance**

The financial statements are prepared in accordance with International Financial Reporting Standards ('IFRS') as adopted by the EU ('EU IFRS'), International Financial Reporting Interpretations Committee ('IFRIC') and in accordance with the Companies Act 2014.

They have been prepared in accordance with those IFRS and International Financial Reporting Interpretations Committee (IFRIC) interpretations issued and effective for accounting periods ending on or before 31 December 2019.

#### **(b) Use of Estimates and Judgements**

The preparation of financial statements in conformity with IFRS requires the use of judgements, estimates and assumptions in determining the value of assets and liabilities, income and expenses recorded for the period and positive and negative contingencies at year-end. Actual results in future financial statements may differ from current estimates due to changes in these assumptions or economic conditions.

There are no critical accounting judgements made in the preparation of the Company's financial statements.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which these estimates are revised and in any future periods affected.

#### ***Other judgements***

When necessary, the company exercises judgement to determine the most appropriate accounting policy that will supply relevant, reliable information for preparation of its financial statements.

**(c) New Accounting Standards and Interpretations**

In the current year, the Company has applied the new/revised IFRS, as set out below, that are mandatorily effective under IFRS, as endorsed by the EU, for accounting periods beginning on or after 1 January 2019. The application of these amendments to standards did not have a material impact on the Company's financial statements for 2019.

The directors consider that the Company's business is not exposed to any foreign exchange risk, market risk or liquidity risk.
